


OPERATING INSTRUCTIONS

The Minuteman X390-1 Back Pack Vac is specifically designed and developed to pick up hazardous dusts and particles, i.e. asbestos, beryllium, radioactive material, etc. This unit is for dry pick-up only. The X390-1 incorporates special filters that reduce the incidence of airborne dust, 99.99% efficient at 0.12 micrometers, created by any other method of vacuuming. At the same time it removes the hazardous material from the area being cleaned.

Warning: To reduce the risk of electrical shock, do not expose to rain. Store machine indoors. Electric motors can cause an explosion when operated near explosive materials or vapors. Do not operate near flammable materials such as solvents, thinners, fuels, grain, dust, etc.

Electrical

This vacuum is designed to operate on a standard 15 amp, 115 volt, 60 hz, AC circuit. Voltages below 105 volts AC or above 125 volts AC cause serious damage to the motor.

To protect the operator from electrical shock, this vacuum must be grounded while in use. This vacuum is equipped with an approved threeconductor power cord and grounding type receptacle.

Maintenance

No lubrication of the motor is required. Motor has sealed lifetime lubricated bearings.

Check the carbon brushes periodically. New brush length is 1 inch. Brushes should be replaced when they reach 3/8 inch in length or after 750 operating hours. Repairs of this nature should always be done by a qualified vacuum repair shop.

Notice

Do not at any time attempt to bypass, remove, substitute or by any other means, change the type filters used in this vacuum. Only use approved Minuteman H.E.P.A. filters and filter bags.

For optimum performance, empty paper bag and clean cloth filter bag regularly. A cloqued and dirty bag restricts the flow of air and results in reduced vacuum.

The Model X390-1 is designed for DRY pick-up ONLY. Do not use for wet pick-up.

Caution: Hazardous materials must be disposed of properly. Never throw contaminated debris in your usual trash receptacle. Place debris in a plastic bag or can marked "HAZARDOUS MATERIALS" and take to a hazardous waste handler.
